

## SEU Flight and Ground Training Fees

Revised April 24, 2023

Effective 2023-24 Academic Year

University students shall be charged fees for flight and ground training delivered by the contracted vendor when enrolled in a corresponding University course.

1. Fees reflect the estimated training required for the average student to complete each course. For students that exceed the estimated cost additional flight hours and/or ground instruction will be billed at prevailing hourly rates. Fees do not include the costs of repeat FAA check-rides or knowledge exams.

2. University reserves the right to impose a fuel surcharge should fuel prices rise dramatically.

3. Students will be refunded unused flight training fees at the prevailing hourly rates if they withdraw prior to completing a course, or complete the course with fewer hours or using less expensive aircraft.

4. Students will be charged a \$100 fee for a no-show on a scheduled flight lesson.
